Muusings from the Minister

Dear friends -

I have been deeply saddened, as I am sure all of you have been, by the reports about the African American high school student, Trayvon Martin, who was shot to death by a "neighborhood watch captain" in Florida. Over time, stories like this can change as new information comes out, but what is indisputable is the interchange that George Zimmerman had with police when he called 911, suspicious of Trayvon. It seems that Zimmerman was already suspicious before he'd even set eyes on Trayvon, because the first thing he says to the officer is, "We've had some break-ins in my neighborhood," thereby putting the sight of a young man in the context of recent break-ins. Later, Zimmerman is heard saying, "These [expletive]s - they always get away." Such comments and the very fact that he had volunteered to watch the neighborhood, create a picture of a man who was looking for trouble before his eyes ever fell upon Trayvon.

The national outrage centers around the "Stand Your Ground" law, which has been cited as the reason that the police have not arrested Zimmerman. These laws remove the requirement, long-standing in British and American legal tradition, that even when we are being attacked, we have an obligation to try to remove ourselves from the situation rather than confronting our attacker.

It is my hope that the investigations which have been undertaken as a result of national outcry will bring the "Stand Your Ground" laws under scrutiny, and that justice will be done for Trayvon. My heart is with all those who have been marching and wearing hoodies with signs that say, "I am Trayvon." He did not deserve to be targeted and killed.

But isn't it also true that we are, oftentimes, George as well? How many times do we "pull the trigger" in thousands of ways, due to our own pre-existing suspicions? How often do we look for trouble because of our previous hurts? How often do we enter into situations or interactions, carrying the past with us in ways that stop us from seeing the real human being under the hoodie? I was just speaking with a young friend who told me about a horrible fight she had with her boyfriend of five years. She suspected him of having made a pass at another woman and she was ready to break up with him. As she was telling me the story of their fight, she said, "You know what? As I'm talking to you, I'm remembering that just before that fight, earlier that day, I had run into an old boyfriend who had cheated on me and I hadn't stood up to him. When I saw him that day, all of my old hurt and anger had come up and I thought to myself that I would never let any man treat me that way again. So when my current boyfriend was talking to that other woman, I think that I was just primed for a fight."

It seems clear that Zimmerman was primed for a fight, and the unwise laws of Florida allowed him both to be carrying a weapon and to act with deadly force on his subjective perception of a threat. As a society, we need laws which discourage the kind of vigilantism that led to Trayvon's death. As individuals, we need to see each person and each situation freshly, leaving behind old hurts and suspicions over and over again so that we can see the face and the heart under the hoodie. Thoughts from Our Field Education Student

The adult RE discussion group met for the first time Sunday, March 11th. I know for many who grew up in non-UU traditions Sunday school might have been a time of memorization where certain questions were met with suspicion. The group of SNUUCers who met for the first discussion group varied in age, gender identification, and religious background. They were not afraid of asking questions and they brought an energy and interest to the class that was far beyond what I was hoping for.

I began with a brief history of the writing of the Old Testament. The story of the Israelites is one of constant struggle. Historically the Israelites developed their society out of the waning conquest of Egypt, only to be conquered by the Assyrians, then the Babylonians, then the Persians, then the Greeks, then the Romans. Each conquest inflicted violence on the people and cultural and religious devastation. So you might reluctantly understand why in Joshua 3 (the passage we read in class) they revel in the story of conquering others, "hereby you shall know that the living God is among you, and that he will without fail drive out from before you the Canaanites, the Hittites, the Hivites, the Perizzites..." etc (Josh 3:10). Archeology and historical records (as reliable as they can be from ancient times) show that the story of the Israelites claiming Canaan, the Promised Land did not really happen. Even later in the Old Testament and New Testament, these same tribes are listed as existing in the land of Canaan. But Native American theologian Robert Allen Warrior argues that it didn't have to happen physically in history to have happened in the imaginations of conquerors for generations. Those Europeans who "drove out" the Native Americans from this Promised Land or enslaved the native people of African and Asian countries. This story has lived in the psyche of the West, and imprinted our collective imagination so deeply we cannot afford to not know it.

At General Assembly this summer, action will be taken to officially denounce and call for the dissolution of The Doctrine of Discovery as a denomination. This Doctrine was a Papal Bull in the 15th century that claimed Christian explorers had the right to conquer new lands if the inhabitants were not Christian. If the people of the land could be converted they could remain. Otherwise it was acceptable, if not expected, that they be enslaved or killed. The US Supreme Court used this Doctrine repeatedly (see Johnson v M'Intosh 1823). Chief Justice John Marshall used this Doctrine to fit the age of discovery into the American dream and our moral standards as a nation. Through these legal procedures, time and again, the request and demand of native peoples for rights to their land are denied. The doctrine was most recently cited in 2005 in the case of City of Sherrill v Oneida Indian Nation of NY, (www.doctrineofdiscovery.org). The UUA is working to be an ally of the United Nations as they work to get the signatures of the most reluctant nations, the United States, Canada, Australia, and New Zealand, on their Declaration on the Rights of Indigenous People.

We will have to work hard to delve into the collective psychology of conquest. So much violence and wrong have been committed toward Native People. We can never do enough to fix what has been broken for Native People around the world, but we'd better get started. I encourage you to read Joshua 3, see how it fits into this UN/UUA Resolution, engage your fellow SNUUCers in conversation, and come to adult RE discussion! Eve Stevens

As board president, in my professional life, and even as a parent, I live by checklists, it seems, so here is a list of to-dos for the next quarter:

Pledge for the 2012-13 fiscal year. Our excellent Stewardship Committee has hosted engaging luncheons and dinners in which members shared their SNUUC stories. Like many of my fellow congregants, I was led here by my children, and have stayed for the friends and community my wife and I have made here. The congregation's most important source of funds for our continued work is member's pledges. Please give from your sustenance, not just from your abundance. Our Treasurer, Peter Larsen and the Board will be scrutinizing numbers in the coming weeks and it is crucial that Stewardship hear from everyone as soon as possible.

Complete financial commitment to SNUUC for 2011-12. As we approach the end of the fiscal year there is always a bit of tension over how close we come to our budgeted projections. Thanks to everyone who has been keeping apace with their current financial commitment to our congregation. Please look ahead and plan to complete your commitment for this year by Father's Day.

Provide budget requests to the Treasurer. Peter does an awesome job keeping tabs on the business of the congregation. He needs input from our committees so he can draft the proposed budget that will go to the Board for review.

Attend the Budget Hearing on May 6. We changed our By-Laws recently and have instituted a required Budget Hearing to be part of our annual budget process. The Treasurer, Finance Committee and the Board will have by this date arrived at a plan for 2012-13. This is the best opportunity to ask questions and confer with the budget makers on how the plan was put together and how we propose to deal with fiscal matters over the following year.

Attend the Congregational Hearing on May 20. This is where our congregation votes on the budget. Per the most recent By-Laws changes, we do not vote on line items at the May annual meeting, but vote on the budget as a whole. So it is very important that any member of the congregation concerned with its fiscal affairs participate in the Budget Hearing.

I think this column might fall into the category that New York Times economics columnist Paul Krugman calls "wonky." But the point, to my mind, is that through participation in our process, we can all feel ownership over SNUUC's present and future, which, I hope, will inspire each of us to live our values more fully. Why Your Pledge Is So Important & a Firm Reminder Your 2012-13 Financial Commitment is due now

We are pleased to report that as of March 25, 2012, we received 43 financial commitments totaling \$77,760, of which 25 increased or were brand-new, six decreased and 12 remained unchanged from last year for a net increase of \$7,645, or nearly 11 percent more than last year for this group.

This is a good result showing a healthy upward trend. But, we are almost at the deadline of April 1, and the canvass of members and pledging friends is less than halfway complete.

So, we appeal to those as yet incomplete: Please make your decisions now. We realize that those of you who could not attend one of the commitment events in March missed an opportunity to have a fuller experience of support for your decision making. So please refer to the letter you received from the Stewardship Committee. And do call upon Ellen Zaehringer, Barbara Singer or Rosemary Olander Beach if you need help or would like to have a conversation more like we had at the events.

Each of the four events was wonderful – convivial, meaningful, helpful. We got to know one another better through sharing our SNUUC journeys and what SNUUC means to us. We discussed perspectives on stewardship and pledging and learned how to use the "guide" -- an important tool to help us make our pledge decisions. **We learned why our pledges are so important.** We learned that we have work to do to Live Our Legacy fully.

Unless you have been following the annual budget process pretty closely, you might not know that members' (and friends') financial commitments provide about half of SNUUC's annual operating budget. The balance is funded by other means – from resources that we are very fortunate to have available to us. These resources include the Thrift Shop's faithful and generous contributions, the Ways & Means Committee's super fundraisers (our beloved Talent Auction and Holiday Fair, etc.), and the savings created by the inspiration and perspiration of many SNUUC members in years before. Our Legacy.

Clearly our individual annual financial commitments are absolutely crucial to SNUUC's financial welfare. Providing 50% of the operating budget seems pretty good, but is it?

Stewardship experts teach us that to achieve true financial health, a self-governing congregation such as SNUUC should fund more like 80% to 90% of its annual operating budget from the direct financial contributions (pledges) of its members.

We have work to do this year and over the next few years, to bring that percentage ever higher.

We will get there by giving from our sustenance, not from our abundance. Follow the "guide."

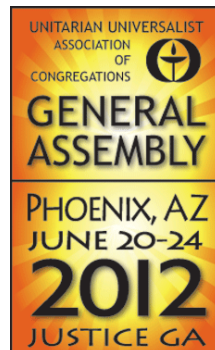
